SUBJECT: Designation of Special and Summary Courts-Martial Jurisdiction

1. The enclosure to this memorandum aligns units for the administration of military justice within the 2d Infantry Division area of jurisdiction, pursuant to 8th Army Supplement 1 to Army Regulation 27-10, and supersedes all previous jurisdiction memoranda. Special Court-Martial Convening Authorities (SPCMCA) exercise jurisdiction over Summary Court-Martial Convening Authorities (SCMCA) listed below them. SCMCA's exercise jurisdiction over the units listed below them.
2. References: Eighth US Army Supplement to AR 27-10, Military Justice.
3. Special and Summary Courts-Martial Jurisdiction for any unit omitted from the attached enclosure will follow the military justice command chain described in the unit's orders. If the unit's orders do not specify a military justice jurisdictional alignment, Special and Summary Courts-Martial jurisdiction will follow the unit's Administrative Command (ADCON) chain. Any unit identified whose orders do not specify either a specific military justice or ADCON chain will be jurisdictionally aligned under Headquarters Support Company, Headquarters and Headquarters Battalion, 2d Infantry Division. Additionally, Commanding General, 2d Infantry Division, serves as the General Court-Martial Convening Authority (GCMCA) for any unit located in Area I whose organic chain-of-command falls outside of Area I (e.g., 2d Sustainment Brigade).
4. Each SPCMCA identified in this enclosure will conduct a quarterly review of the units within his or her jurisdiction and report changes through their servicing Judge Advocate to the 2d Infantry Division Staff Judge Advocate (SJA). The SJA is authorized to update and amend this memo's enclosure per the guidelines articulated in Paragraph 3, *supra*.
