



WARRIOR JUSTICE: Vignette One



FACTS:

A male PFC met a female PV2 at the Camp Casey Lodge for the purposes of having consensual sex. After consuming a large quantity of alcohol, the female PV2 passed out and the male PFC departed. The PFC then returned to his unit barracks and told several of his friends that there was a girl who was passed out at the lodge. He invited them to go back with him to have sex with her. The PFC returned to the hotel and let four other male Soldiers into the hotel room. He shook the female PV2 awake, and then he and another one of the Soldiers he brought with him both penetrated the female PV2 without her consent. The other Soldiers in the room realized that what was happening looked like rape, and left the room without participating.

RECOMMENDED DISCUSSION QUESTIONS:

- What are your thoughts on this situation?
- What could the Soldiers involved do differently?
- Have you observed similar behavior? What did you do?
- How can leaders prevent future incidents?

WARRIOR JUSTICE:

At a General Court-Martial, the male PFC was found guilty of Sexual Assault in violation of Article 120 of the UCMJ. He was sentenced to reduction to Private (E1), to confinement for 6 years, and to a dishonorable discharge.

- What are your thoughts on the action taken against the PFC?



WARRIOR JUSTICE: Vignette Two



FACTS:

A male SGT was in a crowded club. He approached a female SGT and started to dance with her. After a while, the male attempted to kiss her and engage her in a sexually suggestive dance. The female turned away and the male kissed her on the cheek. The female left the club and reported the incident to her supervisor.

RECOMMENDED DISCUSSION QUESTIONS:

- What are your thoughts on this situation?
- What could the SM's involved do differently?
- At what point does one know when they have permission to touch another person?
- Have you observed similar behavior? What did you do?
- How can leaders prevent future incidents?

WARRIOR JUSTICE:

The male SGT was found guilty at a Field Grade Article 15 and was reduced to SPC.

- What are your thoughts on the action taken against the SGT?



WARRIOR JUSTICE: Vignette Three



FACTS:

A male SGT kissed and groped a female PV2 in his unit without her consent on numerous occasions during a four month period. The PV2 ultimately decided to file an unrestricted report and an investigation ensued. The SGT also lied about the incident and gave law enforcement a false official statement about the events.

RECOMMENDED DISCUSSION QUESTIONS:

- What are your thoughts on this situation?
- What could the SM's involved do differently?
- Are you surprised that the SM did not immediately report the behavior?
- Have you observed similar behavior? What did you do?
- How can leaders prevent future incidents?

WARRIOR JUSTICE:

The male SGT was found guilty at a Field Grade Article 15, reduced to SPC, and separated from the military with an other than honorable discharge.

- What are your thoughts on the action taken against the SGT?
