



## 2d Infantry Division / RoK-US Combined Division SOFA Trial Dispositions

3rd Quarter, June 2016 – September 2016



### June 2016

#### (SENIOR LEADER MISCONDUCT)

**Obstruction of Justice.** On 2 June 2016, the Suwon District Court found a **FIRST LIEUTENANT guilty** after trial for striking and choking a Korean National Police Officer. The Soldier was sentenced to a ₩ 5,000,000 fine.

**Indecent Broadcasting.** On 14 June 2016, the Uijeongbu District Court issued a Summary Court Order finding a **PRIVATE guilty** of indecent broadcasting when the Soldier secretly photographed a female Korean National and sent the picture to her boyfriend without her consent. The Soldier accepted the Court Order and was sentenced to a ₩ 2,000,000 fine.

**Fleeing the Scene of Accident.** On 29 June 2016, the Seoul Central District Court found a **SPECIALIST guilty** after trial of veering into a motorcyclist on the highway and leaving the scene. The Soldier was sentenced to confinement for 10 months, not suspended.

### July 2016

**Damage to Private Property and Fraud.** On 1 July 2016, **two PRIVATES FIRST CLASS and two SPECIALISTS were charged** with breaking a taxi's video system and fleeing the taxi without paying their fare. The four Soldiers each paid ₩ 125,000 in a civil settlement with the victim.

**DRIVING UNDER THE INFLUENCE.** On 8 July 2016, the Suwon Appellate Court affirmed a **STAFF SERGEANT'S conviction** for DUI where the Soldier crashed his moped against a vehicle and blew a .235% BAC. The Soldier was sentenced to pay ₩ 3,000,000.

#### (SENIOR LEADER MISCONDUCT)

**DRIVING UNDER THE INFLUENCE.** On 13 July 2016, the Uijeongbu District Court issued a Summary Court Order finding a **First Sergeant guilty** of DUI when the Soldier blew a .074% BAC at a roadside compliance check. The Soldier accepted the Court Order and was sentenced to a ₩ 1,500,000 fine.

#### (SENIOR LEADER MISCONDUCT)

**DRIVING UNDER THE INFLUENCE.** On 13 July 2016, the Seoul Central District Court issued a Summary Court Order finding a **CHIEF WARRANT OFFICER 2 guilty** of DUI where the Soldier blew a .092% BAC. The Soldier accepted the Court Order and was sentenced to a ₩ 1,500,000 fine.

**LARCENY.** On 20 July 2016, the Seoul Central District Court issued a Summary Court Order finding a **SERGEANT guilty** of larceny for stealing a cell phone in a subway station. The Soldier was sentenced to a ₩ 500,000 fine.

## 2d Infantry Division / RoK-US Combined Division SOFA Trial Dispositions

3rd Quarter, June 2016 – September 2016



**OBSTRUCTION OF BUSINESS.** On 20 July 2016, the Seoul Central District Court issued a Summary Court Order **finding a PRIVATE guilty** of obstruction when he failed to pay his cab fare and blamed the taxi driver of stealing a wallet. The Soldier was sentenced to pay ₩ 500,000.

### **August 2016**

**HIT AND RUN.** On 10 July 2016, a **SPECIALIST was arrested and charged** after he struck the front bumper of a car the Soldier was passing and fled the scene. In August, the Soldier made a private settlement with the victim for ₩ 1,220,000.

#### **(SENIOR LEADER MISCONDUCT)**

**ASSAULT.** On 31 July 2016, a **SECOND LIEUTENANT was arrested and charged** with assault when he struck two Korean men in the face at a club in Seoul. In August, the Soldier made a private settlement with the victims by paying ₩ 8,000,000.

**INFLICTION OF BODILY INJURY.** The Uijeongbu District Court **ordered a SPECIALIST to confinement** at Cheonan Prison for failing to pay a fine assessed to him in 2015. The Soldier would have been confined for 30 days to pay off the ₩ 3,000,000 fine at ₩ 100,000 a day, but the Soldier paid the fine before he was to report to Cheonan.

#### **(SENIOR LEADER MISCONDUCT)**

**TRESPASSING.** On 17 August, the Seoul Central District Court **found a CHIEF WARRANT OFFICER 2 guilty** after trial of trespassing into a Korean citizen's home. The Court suspended the ₩ 300,000 sentence for 2 years.

### **September 2016**

#### **(SENIOR LEADER MISCONDUCT)**

**LARCENY.** On 7 August 2016, a **FIRST LIEUTENANT was arrested and charged** with stealing items from a book store on two separate occasions. In September, the Soldier made a private settlement with the storeowner by paying ₩ 1,500,000.
